

## **PRIVACY STATEMENT & COOKIES SK AUCTIONS**

### **Introduction**

SK Auctions is committed to respecting the privacy of the Personal Data of the individuals with whom we interact. We have developed this Privacy Statement to describe how we collect, use and disclose the Personal Data of those individuals who visit our website. We have developed other policies that describe our privacy policies and practices with respect to the processing of personal data of our employees and with respect to the processing of personal data of (representatives of) our customers, suppliers and other parties with whom we interact. By your use of the website, you consent to the processing of your personal data for the purposes set out in this Privacy Statement.

### **What is personal data?**

Personal Data is any information about an identifiable individual, other than the person's business title or business contact information when used or disclosed for the purpose of business communications. Personal Data does not include anonymous or non-Personal Data (i.e., information that cannot be associated with or tracked back to a specific individual).

### **Who is responsible for the processing of your personal data?**

SK Auctions, with registered office Heideelaan 4, 3755MT Eemnes, is responsible for the processing of your personal data, (the "Data Controller"). ### **What personal data do we collect?**

You can visit our website without telling us who you are or revealing any information about yourself, including your e-mail address. Our web server may collect information related to your visit to our website, including the IP address and domain used to access our website, the type and version of your browser, the website you came from to access our website, the page you entered and exited at, any website page that is viewed by that IP address and what country you are from. We use this information to monitor our website's performance (such as number of visits, average time spent, page views) and for our business purposes such as working to continually upgrade our website. In addition, we collect the Personal Data that you submit to our website, such as your name, address and any other contact or other information that you choose to provide by: • using the "contact" or "register" forms on this website; • by corresponding with a representative of SK Auctions via e-mail using the links created for that purpose.

### **How do we use cookies?**

When you visit the website, we may place a "cookie" on the hard drive of your computer to track your visit. A cookie is a small data file that is transferred to your hard drive through your web browser that can only be read by the website that placed the cookie on your hard drive. The cookie acts as an identification card and allows our website to identify you and to record your passwords and preferences. The cookie allows us to track your visit to the website so that we can better understand your use of our website so that we can customize and tailor the website to better meet your needs. You can accept or reject cookies. Most internet browsers automatically accept cookies, although you can change your browser settings to reject cookies if you like. If you decide to switch off cookies, it is possible that some graphical elements no longer appear at their best, or that you are no longer capable to use certain features of SK Auctions. You can find more information on how you can change or adjust the settings of your browser, in the user manual or help function of your internet browser.

### **What about links to other websites?**

Our website may contain links to other websites that may be subject to less stringent privacy standards. We cannot assume any responsibility for the privacy practices, policies or actions of the third parties that operate these websites. SK Auctions is not responsible for how such third parties collect, use or disclose your Personal Data. You should review the privacy policies of these websites before providing them with Personal Data.

### **Why do we collect, use and disclose personal data?**

The Personal Data collected is used and disclosed for the following purposes: • to contact you if you have requested to be contacted by means of the contact form; • to send you (personalized) marketing, advertising, and promotional messages and other information that may be of interest to you, in relation to the products, services and events provided by SK Auctions. You can unsubscribe or opt-out from receiving these communications via the link in the marketing correspondence. If the sharing of data is required for the aforementioned purposes, your personal data can be disclosed to third party service providers who require such information to assist us with establishing, maintaining and managing our relationship with you. In some instances, such parties may also provide certain information technology and data processing services to us so that we may operate our business. In those cases, third party service providers who process personal data on behalf of SK Auctions, if any, will be required to take appropriate technical and organizational measures to protect the security of that data, and to act only in accordance with the instructions of SK Auctions in respect of the processing of such data. Your data will be stored exclusively in the Netherlands. Personal Data may furthermore be disclosed or transferred to another party in the event of a change in ownership of, or a grant of a security interest in, all or a part of SK Auctions. We may collect, use or disclose your Personal Data without your knowledge or consent where we are permitted or required by applicable law or regulatory requirements to do so. Except as otherwise permitted or required by applicable law or regulatory requirements, SK Auctions endeavors to retain Personal Data only for as long as it believes is necessary to fulfill the purposes for which the Personal Data was collected (including, for the purpose of meeting any legal, accounting or other reporting requirements or obligations). If destroying or erasing Personal Data is not mandatory by law, we may make it anonymous such that it cannot be associated with or tracked back to the individual. If you are contacting us from Europe through our website, we may disclose your personal data (including a person's business title or business contact information when used or disclosed for the purpose of business communications) to the relevant European affiliate(s) or dealers of SK Auctions in order for them to answer your request and to provide you with any assistance needed. The processing of your personal data will then be regulated by the applicable privacy policies that apply to the processing by the relevant European affiliate(s).

### **Your personal data is important to us**

By using our website, we assume that you have read and understood the information about the collection, use and disclosure of your Personal Data as explained in this privacy statement. You can ask to see the Personal Data that we hold about you. For information on accessing your Personal Data and your rights as an individual, please see our website.

### **How is your personal data protected?**

Placing hyperlinks to our websites is only allowed if these hyperlinks lead to the homepage of the site. Deep linking is not permitted without the prior written consent of SK Auctions. The use of our websites on sites or on parts of third-party websites (such as through in-line linking, framing or any other means) is also forbidden. SK Auctions endeavors to maintain physical, technical and

procedural safeguards that are appropriate to the sensitivity of the Personal Data in question. These safeguards are designed to protect your Personal Data from loss and unauthorized access, copying, use, modification or disclosure. Unfortunately, no data transmission over the internet can be guaranteed to be 100% secure. As a result, while this website strives to protect your Personal Data, we cannot warrant the security of any information you transmit to us, and you do so at your own risk. Once this website receives your transmission, we make commercially reasonable efforts to ensure its security on our systems.
